RESOLUTION NO. 2004-050

A RESOLUTION APPROVING ORDINANCE NO. 2004-01 OF THE
BARANGAY COUNCIL OF BARANGAY KADAHAN, ENTITLED: "AN
ORDINANCE IMPLEMENTING THE CLEANLINESS AND SANITATION
PROGRAM OF THE CITY GOVERNMENT OF ORMOC, ENCOURAGING
RESIDENTS IN CLEANING ITS SURROUNDINGS (SIC) AND
PROHIBITING THEM FROM THE INDISCRIMINATE THROWING OF
GARBAGE, AND ANY DOMESTIC WASTE MATERIALS, PROVIDING
PENALTIES FOR VIOLATION THEREOF".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 2004-01 of
Barangay Kadahan, this city, entitled: "AN ORDINANCE IMPLEMENTING THE
CLEANLINESS AND SANITATION PROGRAM OF THE CITY GOVERNMENT OF ORMOC,
ENCOURAGING RESIDENTS IN CLEANING ITS SURROUNDINGS (SIC) AND PROHIBITING
