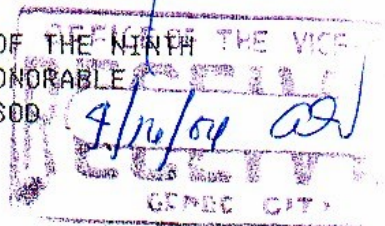

A RESOLUTION APPROVING THE RESOLUTION OF BRGYS. NAUNGAN, LAO AND SAN JUAN ESTABLISHING A MANGROVE RESERVE AREA AND BIRD SANCTUARY FOR THE PROTECTION OF INDIGENOUS FLORA AND FAUNA.

WHEREAS, this Sanggunian is in receipt of a letter addressed to Hon. Eduardo P. Tan, Chairman, CENR from Engr. Juliana P. Flores, Supv. Env'l, Mngt. Specialist, recommending, affirming and requesting for the declaration of the 175 hectares of mangrove area as Mangrove Reserve and Bird Sanctuary of Brgys. Naungan, Lao and San Juan;


