A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC  
C. CODILLA TO ENTER INTO CONSULTANCY AGREEMENT WITH DR.  
SAMUEL S. GO AS CONSULTANT ON AGRICULTURE.

WHEREAS, this Sanggunian is in receipt of a letter dated 12 August  
2004 from the Honorable City Mayor Eric C. Codilla, requesting for the  
passage of a resolution authorizing him to enter into a contract for and  
in behalf of the City Government of Ormoc with Dr. Samuel S. Go, who  
will render as consultant on Agriculture, this city;

WHEREAS, said letter also mentioned the Terms and References  
regarding said contract as follows:

1. Act as consultant on Agriculture and rural development in the  
implementation of Rice Farm Input Assistance for one (1) year  
and one half (1/2) starting August 2004 to February 2006  
renewable;
2. Must assist the City Agricultural Services Office (CASO) in  
the preparation of development plans, programs and projects;
3. Must receive an honorarium level to the salary of Division  
head of LGU Ormoc;
4. Must be given travelling expenses and per diems when rendering  
official travel;



5. Must submit reports monthly to the Office of the City Mayor copy furnish Chairman Committee on Agriculture, City Accounting and CASO;
6. Perform such other related functions as may be requested by the Local Government of Ormoc through the City Mayor;

WHEREAS, this august Body believes that said request is reasonable and meritorious, hence, the same be given due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, duly seconded by City Councilor Jose C. Alfaro, Jr.; be it




