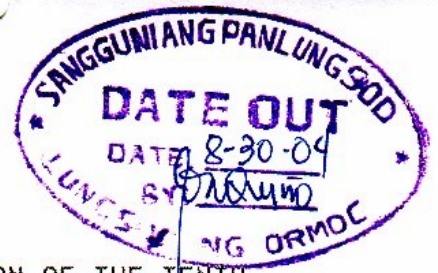

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.  
CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE  
CITY OF ORMOC, THE PHILIPPINE TOURISM AUTHORITY AND THE  
CONGRESSIONAL FOURTH DISTRICT OF LEYTE FOR THE  
COMPLETION OF VIEW DECK AND RESTROOMS LOCATED AT LAKE  
DANAO, THIS CITY.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 26  
August 2004 from the Honorable City Mayor Eric C. Codilla requesting for  
authority to sign the Memorandum of Agreement (MOA) between the City of  
Ormoc, the Philippine Tourism Authority and the Congressional 4th  
District of Leyte for the Completion of View Deck and Restrooms located  
at Lake Danao, this city;

WHEREAS, said Memorandum of Agreement (MOA) mentions of the  
responsibilities of each party and other covenants pertaining to said  
project for the benefit and enjoyment of foreign as well as domestic  
tourists and the general public;

WHEREAS, it is recommended that prior to the implementation of the  
said project, consultation and coordination with the Protected Area  
Management Board (PAMB) must first be made;

WHEREAS, this august Body believes that said request is  
meritorious, hence, the same be accorded the necessary course of action;

WHEREFORE, foregoing premises considered, on motion of City  
Councilor Fe S. Lladoc, Chairman, Committee on Tourism, duly seconded by
