

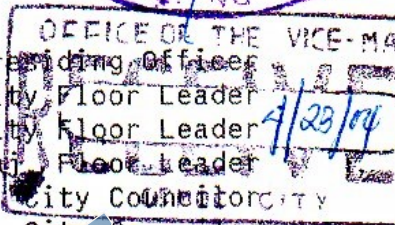



ADOPTED, April 22, 2004.


