RESOLUTION NO. 2004-063

A RESOLUTION CONCURRING THE APPOINTMENT OF DR. DENNIS Y. CAPUYAN AS CITY GOVERNMENT DEPARTMENT HEAD I (CITY ADMINISTRATOR) EFFECTIVE AUGUST 13, 2004.

PRESENTED, to this august Body for consideration is 1st Indrosement dated 27 August 2004 from the Honorable City Mayor Eric C. Codilla re: appointment of Or Dennis Y. Capuyan as City Government Department Head I (City Administrator) effective August 13, 2004;

WHEREAS. Article 119, Paragraph (a) Rules and Regulations Implementing the Local Government Code of 1991 provides:

"(a) Unless otherwise provided in this Rules, heads of offices and department in the LGU's shall be appointed by the Local Chief Executive concerned with the concurrence of a majority of all the members of the Sanggunian, subject to civil service laws, rules and regulations."(underscoring supplied)

WHEREAS, this august Body through the representation of Honorable Vice Chairman, Committee on Good Government & Ethics, found out that the appointment of Dr. Dennis Y. Capuyan to the said position is in accordance with pertinent provisions of the Local Government Code of 1991;

WHEREFORE, foregoing premises considered, on motion of Councilor Mariano Y. Corro, Vice Chairman, Committee on Good Government and Ethics, jointly seconded by City Councilors Sotero M. Pepito & Eduardo P. Tan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution CONCURRING APPOINTMENT OF DR. DENNIS Y. CAPUYAN AS CITY GOVERNMENT DEPARTMENT HEAD I (CITY ADMINISTRATOR) EFFECTIVE AUGUST 13, 2004;
