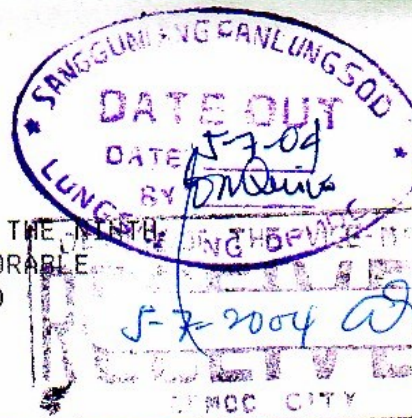


ADOPTED, May 06, 2004.


