WHEREAS, this Sanggunian is in receipt of Barangay Resolution No. 05 S. 2004 from the Barangay Council of Barangay Salvacion, this city, embodying Tax Ordinance No. 01 S. 2004 entitled: "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, SIGNS, SIGNBOARD AND BILLBOARDS AND FOR OTHER PURPOSES;"

WHEREAS, aforementioned Ordinance was previously returned to the Sangguniang Pambarangay of Salvacion for the reason that the basis used in imposing the tax was on <u>Capital Investment</u>, instead of Gross Sales or Receipts of the preceding calendar year, as provided for in Sec. 152, LGC;

WHEREAS, the re-submitted Ordinance now conforms to the requirements of the law particularly the aforecited Sec. 152, LGC;
