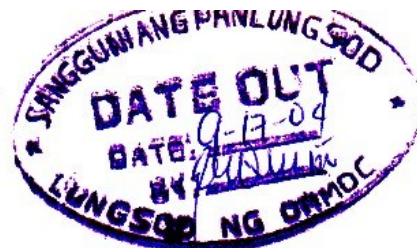

RESOLUTION NO. 2004-067

A RESOLUTION DESIGNATING HONORABLE CITY COUNCILOR JOSE C.
ALFARO, JR., CHAIRMAN, COMMITTEE ON POLICE, AS MEMBER
OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB), ORMOC
CITY, VICE THEN CITY COUNCILOR DEMOSTHENES F. TUGONON.

WHEREAS, the People's Law Enforcement Board of Ormoc City was
created through SP Resolution No. 39 dated 13 August 1992 in pursuance
to Republic Act 6975 particularly Section 43 par. (a) thereof;

WHEREAS, under said law, the People's Law Enforcement Board (PLEB),
is tasked to hear and decide citizen's complaints or cases filed before
it against erring officers and members of the PNP within the
jurisdiction of Ormoc City;

WHEREAS, Section 43, par 13 of the aforementioned RA 6975, provides for
the composition of the PLEB as follows:

"1. Any member of the Sangguniang Panlungsod/Bayan chosen by
his respective sanggunian;

this Sanggunian has reached a consensus to indorse City Councilor Jose

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution DESIGNATING HONORABLE CITY COUNCILOR JOSE C. ALFARO, JR., CHAIRMAN, COMMITTEE ON POLICE, AS MEMBER OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB), ORMOC CITY, VICE THEN CITY COUNCILOR DEMOSTHENES F. TUGONON;
