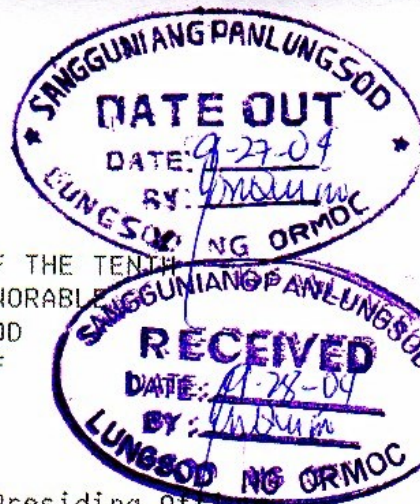

RESOLUTION NO. 2004-068

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BETWEEN THE NATIONAL IRRIGATION ADMINISTRATION, THE BARANGAY GOVERNMENT OF LILO-AN, AND THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 07 September 2004 re: Barangay Resolution No. 32 S. 2004 of Barangay Lilo-an entitled: "A RESOLUTION EARNESTLY REQUESTING THE NATIONAL IRRIGATION ADMINISTRATION THRU IRRIG. SUPT. ANTONIO A. VIZCARRA, MSME, TO TRANSFER THE ADMINISTRATION AND MAINTENANCE OF NIA ROAD WITHIN THE JURISDICTION OF BARANGAY" and MOA between the National Irrigation Administration, the Brgy. Government of Lilo-an and the City Government of Ormoc;
