WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 07 September 2004 re: Barangay Resolution No. 32 S. 2004 of Barangay Liloan entitled: "A RESOLUTION EARNESTLY REQUESTING THE NATIONAL IRRIGATION ADMINISTRATION THRU IRRIG.
