A RESOLUTION CONCURRING AND SUPPORTING RESOLUTION NO. 230 S. 2004 OF THE SANGGUNIANG PANLALAWIGAN OF COTABATO, ENTITLED: "RESOLUTION VEHEMENTLY OPPOSING THE POWER RATE ADJUSTMENT BEING IMPOSED BY THE NATIONAL POWER CORPORATION (NPC) FOR REASONS CITED HEREIN."

WHEREAS, this Sanggunian is in receipt of Resolution No. 230 s. 2004 of the Sangguniang Panlalawigan of Cotabato, entitled: "RESOLUTION VEHEMENTLY OPPOSING THE POWER RATE ADJUSTMENT BEING IMPOSED BY THE NATIONAL POWER CORPORATION (NPC) FOR REASONS CITED HEREIN;"

WHEREAS, said resolution mentions of the act of increasing or adjusting the power rate by NPC by as much as 30% - 50% of the total kilowatt usage for the month which is not only untimely but also unreasonable and unjust there being no bunker oil used;
