A RESOLUTION APPROVING THE CITY DEVELOPMENT COUNCIL (CDC)
EXECUTIVE COMMITTEE RESOLUTION NO. 01 SERIES OF 2004,
ENTITLED: "A RESOLUTION APPROVING THE REALIGNMENT OF
ROAD REHABILITATION/IMPROVEMENT/REPAIR AT SITIO
KANDANAO, BRGY. MANLILINAO IN THE AMOUNT OF FIVE
HUNDRED THOUSAND PESOS (P500,000.00) TO BARANGAY SITE
DEVELOPMENT IN THE SAME AMOUNT AT THE SAME BARANGAY AND
REQUESTING THE HONORABLE SANGGUNIANG FOR THE APPROVAL
OF THE SAME."

WHEREAS, the 10th Sangguniang Panlungsod ng Ormoc is in receipt of
1st Indorsement dated 20 September 2004 from the Office of the City
Mayor Eric C. Codilla, endorsing the above-mentioned resolution;

WHEREAS, during the CDC Executive Committee Meeting, Engr. Jovencio
A. Laurente informed the council that the Five Hundred Thousand Pesos
(P500,000.00) is not sufficient for the above project and it is more
appropriate to realign the said amount to Barangay Site Development to
maximize the utilization of funds;

WHEREAS, the Sangguniang Barangay of Brgy. Manlilinao has expressly
manifested its request for the said project by passing Resolution No.
2004-00, entitled: "A RESOLUTION EARNESTLY REQUESTING THE HONORABLE CITY
MAYOR ERIC C. CODILLA, FOR THE REALIGNMENT OF FUNDS APPRIATED (SIC) BY
THE CITY GOVERNMENT FOR THE ROAD REHABILITATION/IMPROVEMENT/REPAIR AT

BARANGAY MANLILINAO (SITIO CANDANAO) IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) TO BARANGAY SITE DEVELOPMENT OF THE BARANGAY;"

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructure, duly seconded by City Councilor Sotero M. Pepito; be it

RESOLVED, to pass a resolution APPROVING THE CITY DEVELOPMENT COUNCIL (CDC) EXECUTIVE COMMITTEE RESOLUTION NO. 01 SERIES OF 2004, ENTITLED: "A RESOLUTION APPROVING THE REALIGNMENT OF ROAD REHABILITATION/IMPROVEMENT/REPAIR AT SITIO KANDANAO, BRGY. MANLILINAO IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) TO BARANGAY SITE DEVELOPMENT IN THE SAME AMOUNT AT THE SAME BARANGAY AND REQUESTING THE HONORABLE SANGGUNIAN FOR THE APPROVAL OF THE SAME;"
