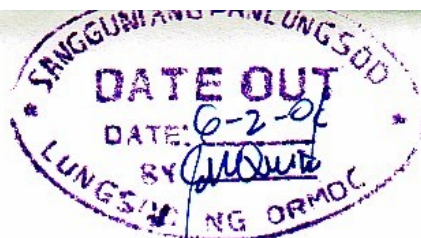

Councilor Rafael C. Omega, Jr.; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass an omnibus resolution


RESOLVED, FURTHER, to furnish copies of this resolution each to His
