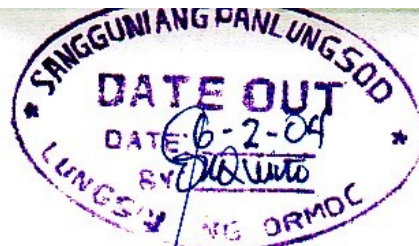

A RESOLUTION REQUESTING THE BUREAU OF FIRE PROTECTION

FIRETRUCK WITH FIREMEN AND PNP PERSONNEL RESPECTIVELY,
TO BE STATIONED AT THE EXECUTIVE BUILDING OR AT THE
SANGGUNIANG PANLUNGSOD PREMISES AND TO RENDER 24 HOUR-
DUTY FOR THE ENTIRE DURATION OF THE ORMOC CITY FIESTA
CELEBRATION.

WHEREAS, the City of Ormoc will be celebrating its Annual Fiesta
Celebration come June 29-30, 2004 in honor of its Patron, Saints Peter &
Paul;

WHEREAS, in relation to the said celebration, many makeshift stalls
and other kiosks are visibly present in the city plaza as well as in the
surroundings of the Executive and the Sangguniang Panlungsod Buildings
selling their goods to the general public;

WHEREAS, with the existence of these stalls which are even used as
temporary houses, this Sanggunian believes that the same are prone to
fire and other dangers, hence, this request;

WHEREFORE, foregoing premises considered, on MASS MOTION of the
Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING
THE BUREAU OF FIRE PROTECTION CHIEF AND THE PNP CITY DIRECTOR, THIS CITY


