CODILLA, TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT (MOA), TO BE ENTERED INTO BETWEEN THE HOUSING AND LAND USE REGULATORY BOARD (HLURB) AND THE CITY GOVERNMENT OF ORMOC, FOR THE FORMULATION OF A "GIS COOKBOOK FOR LGUs" (GUIDELINES FOR THE PREPARATION OF A COMPREHENSIVE LAND USE PLANNING USING GIS).

WHEREAS, this Sanggunian is in receipt of a letter dated 27 September 2004 from the Honorable City Mayor Eric C. Codilla, urgently requesting for immediate response regarding the MOA between the City Government of Ormoc and the HLURB;

WHEREAS, said MOA mentions of the need to update the Comprehensive Land Use Plan (CLUP) guidelines to incorporate the use of GIS Technology in the preparation of Land Use Plans for LGUs as a tool in their Planning activities and that the SWEDISH INTERNATIONAL DEVELOPMENT COOPERATION AGENCY (SIDA) is providing technical assistance to prepare a guidelines for LGUs called "GIS COOKBOOK FOR LGUs;

WHEREAS, having been identified as one of the study areas for the said project, the Sangguniang Panlungsod ng Ormoc believes that said MOA is reasonable, hence, the same be given due course of action;
