A RESOLUTION APPROVING ORDINANCE NO. 2004-01 OF THE
BARANGAY COUNCIL OF BARANGAY DOMONAR, THIS CITY,
ENTITLED: "AN ORDINANCE PROHIBITING OWNERS OF DOMESTIC
ANIMALS, SUCH AS PIGS, CATTLE, GOATS, DOGS, HORSES, AND
FOWLS AS TURKEYS, GEESE, AND SIMILAR ANIMALS AND FOWLS,
FROM CAUSING THEM TO GO ASTRAY, PROVIDING PENALTIES IN
VIOLATION THEREOF."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
01, Series of 2004 from the Barangay Council of Barangay Domonar,
entitled: "AN ORDINANCE PROHIBITING OWNERS OF DOMESTIC ANIMALS, SUCH AS
PIGS, CATTLE, GOATS, DOGS, HORSES, AND FOWLS AS TURKEYS, GEESE, AND
SIMILAR ANIMALS AND FOWLS, FROM CAUSING THEM TO GO ASTRAY, PROVIDING
PENALTIES IN VIOLATION THEREOF";
