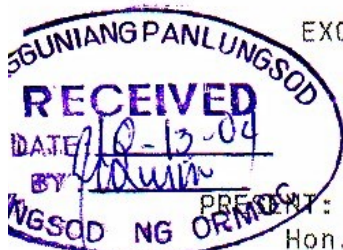
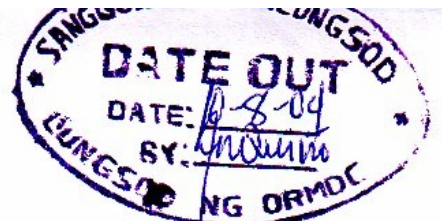

age of 65;

WHEREAS, the late Celso P. Adolfo was a resident of Ormoc City, a

a Resident Physician of Southern Islands Hospital, Cebu City from July

March 27, 1998; Elected City Vice Mayor on July 01, 1998 to June 30,
2004;
