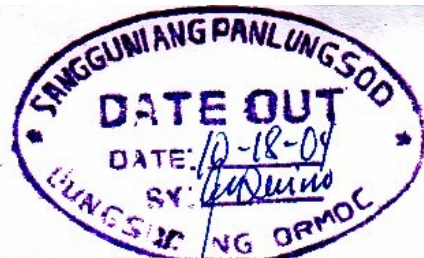
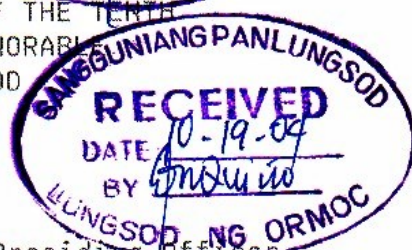

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC A MEMORANDUM OF AGREEMENT, TO BE ENTERED INTO BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY JIM N. REBUSTILLO, REGIONAL DIRECTOR AND THE CITY GOVERNMENT OF ORMOC, RELATIVE TO THE PGMA'S MICRO-FINANCING AND ENTERPRISE DEVELOPMENT PROGRAM.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 04 October 2004 from the Office of the City Mayor requesting for authority to enter into a Memorandum of Agreement (MOA) with Jim N. Rebustillo, Regional Director, DSWD relative to the PGMA's Micro-Financing and Enterprise Development Program;

WHEREAS, the DSWD implements the Self-Employment Assistance Kaunlaran (SEA-K) Integrated Program as its main tool in providing capability building for sustained financial facilities for beneficiaries belonging to the poverty group;

WHEREAS, under said MOA, the Ormoc LGU commits itself to provide technical assistance and other support to the program in order to uplift the living condition of the disadvantaged sector and be productive member of the community;


