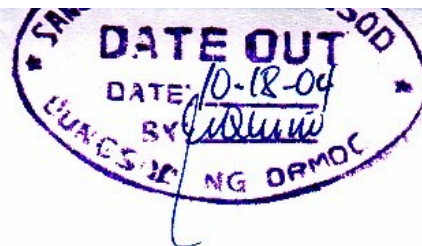

RESOLUTION NO. 2004-088

A RESOLUTION INTERPOSING NO OBJECTION AND RECOMMENDING TO THE OFFICE OF THE CITY MAYOR, HON. ERIC C. CODILLA TO ALLOW BARANGAY DON FELIPE LARRAZABAL TO USE A PORTION OF LAND CONTAINING EIGHTY SEVEN (87) SQ. M. MORE OR LESS, AS PER SKETCH PLAN ATTACH HERETO, PROVIDED HOWEVER, THAT THE SAID LOT SHALL AUTOMATICALLY REVERT TO THE CITY (TOGETHER WITH ANY AND ALL IMPROVEMENTS FOUND THEREON) IF THE PURPOSE FOR WHICH IT IS INTENDED CEASES TO EXIST OR IF THE AREA BECOMES AN EYESORE IN RELATION TO THE CITY'S CLEAN AND GREEN PROGRAM.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of a resolution from the Sangguniang Barangay of Don Felipe Larrazabal requesting for the use or donation of a lot containing 87 sq.m. more or less to be used as Brgy. Tanod Outpost with Jail and Livelihood Training Center;

WHEREAS, upon verification by the City Surveyor, Engr. Arthur C. Arcuino, said lot was formerly a City Road, a part of Osmeña Extension, and therefore a property of the city;

WHEREAS, the City Planning & Development Office recommends that the said construction be in conformity with the motif in the area;

WHEREAS, this august Body believes that said request is reasonable, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Public Properties, duly seconded by City Councilor Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INTERPOSING NO OBJECTION AND RECOMMENDING TO THE OFFICE OF THE CITY MAYOR, HON. ERIC C. 
ADOPTED, October 15, 2004.
