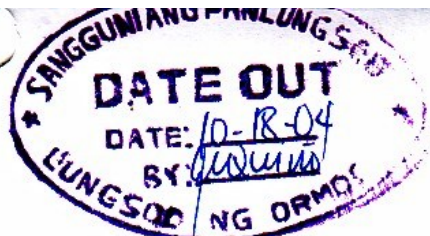

by City Councilor Gregorio A. Yrastorza, Jr.; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION APPROVING
