RESOLUTION NO. 2006-001

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE AMENDED MEMORANDUM OF AGREEMENT BY AND BETWEEN THE PHILHEALTH INSURANCE CORPORATION (PHIC) AND THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 19 December 2005 from the Office of the City Mayor requesting for authority to enter into and sign the Amended Memorandum of Agreement between Philippine Health Insurance Corporation (PHIC) and the City Government of Ormoc;

WHEREAS, there is an existing Memorandum of Agreement between the PHIC and the City Government of Ormoc, which MOA was executed last 2000 by then - Mayor Eufrocino M. Codilla, Sr., on behalf of the City Government of Ormoc and Enrique M. Zalamea, Jr., President and CEO on behalf of the PHIC;

WHEREAS, changes have been made in the provisions of the Memorandum of Agreement between the City Government of Ormoc, the Province of Leyte and Phil Health particularly on the matter affecting the enrollment and premium sharing schemes of the Sponsored Program (Indigent Program), thus, necessitating for the amendment of the existing MOA and come up with a revised Memorandum of Agreement;

WHEREAS, this august Body believes that said request is reasonable and must be accorded with the necessary course of action;
