A RESOLUTION AUTHORIZING THE HONORABLE ERIC C. CODILLA TO INTO AND SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE COALITION AGAINST TUBERCULOSIS AND THE DEPARTMENT OF HEALTH.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 17 November 2005 from the Office of the City Mayor requesting the Honorable Vice Mayor & Presiding Officer, 10th Sangguniang Panlungsod this city to grant authority to the Hon. Eric C. Codilla, City Mayor, to enter into sign for and in behalf of the City Government of Ormoc the Memorandum of Agreement between the City Government of Ormoc, Philippine Coalition Against Tuberculosis and the Department of Health;

WHEREAS, the objective of said Memorandum of Agreement (MOA) is to effect a more efficient TB Control Program in Region VIII particularly in Ormoc City considering that there is an urgent need to adopt a comprehensive and unified policy for a standardized and a manageable approach for diagnosis, treatment and control of TB;

WHEREAS, this august Body believes that said request is reasonable considering that Tuberculosis remains a major public health problem in the Philippines with 75 Filipinos dying of TB each day, thus, the same be given the necessary course of action;

WHEREFORE, foregoing premises considered, on motion of Councilor Ruben R. Capahi, Chairman, Committee on Health, duly seconded by City Councilor Sotero M. Pepito; be it
