


RESOLUTION NO. 2006-010

A RESOLUTION APPROVING THE REQUEST OF ORMOC MATERNITY AND
CHILDREN'S HOSPITAL (OMCH) TO WITHDRAW THEIR CASH
DEPOSIT FROM THE CITY TREASURER OF ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of a Resolution No. ____ S.
of 2005 from the Ormoc Maternity and Children's Hospital, entitled: "A
RESOLUTION EXPRESSING THE DESIRE OF THE BOARD OF DIRECTORS OF THE OMCH
TO BE AN INDEPENDENT ENTITY FROM THE CITY GOVERNMENT OF ORMOC FOR
FINANCIAL ADMINISTRATION AND ALLOWING THEM TO WITHDRAW THEIR CASH
DEPOSIT FROM THE CITY TREASURER OF ORMOC CITY." (Copy of which is hereto
attached for ready reference).;

WHEREAS, the aforementioned resolution of OMCH was Indorsed to the
City Treasurer and City Accountant for their comments, and
recommendations;

WHEREAS, City Treasurer Angelo I. Roman per his 3rd Indorsement
dated January 2, 2006 recommended "for the approval to withdraw their
funds from the City Government of Ormoc, provided that the amount to be
withdrawn is subject to the closing of books as of December 31, 2005,
provided further that handling of books of accounts and the related
functions of handling and disposition of funds shall be transferred to
Ormoc Maternity and Children's Hospital Incorporated effective January
6, 2006 as per letter to the City Mayor, this city dated October 3, 2005
attached";

WHEREAS, City Accountant Rosalinda S. Muyuela, per her 5th Indorsement dated January 9, 2006 has stated therein "that we are still in the process of recording and closing of books of accounts of OMCH Calendar Year 2005 to determine the ending cash balance of OMCH after recording of all transactions to be processed in the city most probably in the 1st week of February 2006, thereby transferring also the handling and disposition of funds as well as the keeping of the books of accounts in the custody of OCMH effective January 1, 2006";

WHEREAS, the Office of the City Mayor per their 7th Indorsement dated January 10, 2006 has requested this Sanggunian through the Honorable Vice-Mayor and Presiding Officer "for a legislative action, with a favorable recommendation from this Office on the request entitled: "A RESOLUTION EXPRESSING THE DESIRE OF THE BOARD OF DIRECTORS OF THE OMCH TO BE AN INDEPENDENT ENTITY FROM THE CITY GOVERNMENT OF ORMOC FOR FINANCIAL ADMINISTRATION AND ALLOWING THEM TO WITHDRAW THEIR CASH DEPOSIT FROM THE CITY TREASURER OF ORMOC CITY", Recommending further that the annual subsidy of ₱125,000.00 be stopped for the reason that Ormoc Maternity and Children's Hospital is a private corporation;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman Committee on Laws & Ordinances, jointly seconded by City Councilors Jose C. Alfaro, Jr. & Manuel T. Fiel; be it

RESOLVED AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING THE REQUEST OF ORMOC MATERNITY AND CHILDREN'S HOSPITAL (OMCH) TO WITHDRAW THEIR CASH DEPOSIT FROM THE CITY TREASURER OF ORMOC CITY;

ADOPTED, January 20, 2006.
