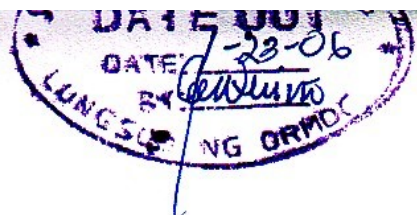

A RESOLUTION FAVORABLY ENDORSING THE REQUEST OF BARANGAY LILO-AN, THIS CITY, FOR THE ESTABLISHMENT OF AN ADDITIONAL SECONDARY SCHOOL TO BE KNOWN AS LILO-AN NATIONAL HIGH SCHOOL PER BARANGAY RESOLUTION NO. 19 S. 2005.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 4 October 2005 from the Office of the City Mayor re: Barangay Resolution No. 19 s. 2005 of Barangay Lilo-an, entitled: "A RESOLUTION EARNESTLY REQUESTING THE SANGGUNIANG PANLUNGSOD OF ORMOC CITY THROUGH THE HONORABLE CITY MAYOR, ERIC C. CODILLA FOR THE ESTABLISHMENT OF AN ADDITIONAL SECONDARY SCHOOL TO BE KNOWN AS LILO-AN NATIONAL HIGH SCHOOL AT BARANGAY LILO-AN, ORMOC CITY";


