A RESOLUTION GRANTING THE HONORABLE CITY MAYOR ERIC C. CODILLA, AUTHORITY TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT BY AND BETWEEN THE BUREAU OF INTERNAL REVENUE AND THE CITY GOVERNMENT OF ORMOC, FOR THE "MANGAYO TA UG RESIBO PA RAFFLE PROMO".

WHEREAS, this Sanggunian is in receipt of an Indorsement dated January 16, 2006 from the Office of the City Mayor of Ormoc, urgently requesting for the passage of a resolution granting Hon. City Mayor Eric C. Codilla for an authority to enter and sign the Memorandum of Agreement by and between the BUREAU OF INTERNAL REVENUE and the City Government of Ormoc for the "Mangayo Ta Ug Pa Raffle Promo"

WHEREAS, in the aforementioned Indorsement it is stated therein that "the total amount of One Hundred Fifty Three Thousand (P153,000.00) for the prizes shall be taken from the account of this office. The month of January shall not be included in the computation, for your information";


