A RESOLUTION AUTHORIZING THE CITY TREASURER TO DEPOSIT UNDER A HIGH YIELD SAVINGS ACCOUNT (HYSA) THE AMOUNT PAID BY PROC-EDC FOR THE BUSINESS TAXES OF CE LUZON GEOTHERMAL POWER COMPANY (CE-LUZON) AND VISAYAS GEOTHERMAL POWER COMPANY (VGPC) FOR CALENDAR YEARS 2001-2006 AMOUNTING TO P152,636,466.00.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 25 Jahuary 2006 from the Office of the City Mayor re: Letter from the City Treasurer requesting for a resolution authorizing him to deposit under High Yield Savings Account (HYSA) the amount paid by PNOC-EDC for business taxes of CE Luzon Geothermal Power Company (CE-Luzon) and Visayas Geothermal Power Company (VGPC) for Calendar Year 2001-2006 in the amount of P152,636,466,00 at the LandBank of the Philippines, Ormoc Branch;
