RESOLUTION NO. 2006-029

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO INTERVENE IN BOTH CE CEBU AND VGPC CASES NOW PENDING WITH RTC BRANCH 35, ORMOC CITY SINCE PNOC-EDC SHALL ALSO BE IMPEADED BY THE MUNICIPALITY OF KANANGA, AND TO INSTITUTE ANY LEGAL ACTION AND ADOPT ANY LEGAL MEANS FOR THE INVALIDITY OF THE COMPROMISE AGREEMENT DATED MARCH 27, 2003 BETWEEN THE CITY OF ORMOC AND THE MUNICIPALITY OF KANANGA, AS RECOMMENDED BY CITY PROSECUTOR AND ACTING CITY LEGAL OFFICER PER HIS LETTER DATED FEBRUARY 7, 2006, COPY OF WHICH IS HERETO ATTACHED FOR READY REFERENCE.

WHEREAS, this Sanggunian is in receipt of an indorsement dated February 7, 2006 from the Office of the City Mayor, urgently requesting for the passage of a resolution granting authority to the Hon. Mayor Eric C. Codilla, to intervene in both the CE Cebu and VGPC cases since PNOC-EDC shall also be impeaded by the Municipality of Kananga in said cases, and further to grant the City Mayor an authority to institute legal action to declare the Compromise Agreement dated March 27, 2003 between the City of Ormoc and the Municipality of Kananga, as recommended by City Prosecutor and Acting City Legal Officer per his letter dated February 7, 2006 null and void;

WHEREAS, in aforecited indorsement, it is stated: "Request for urgency is hereby ask for in view of the fact that the cases is (SIC) already pending with RTC Branch 35, this city";



WHEREAS, this urgent request for the passage of subject resolution is an off-shot of the letter dated February 7, 2007 of City Prosecutor and Acting City Legal Officer, James Clinton C. Nuevo, to the Honorable City Mayor Eric C. Codilla, copy of said letter is hereto attached for ready reference;

WHEREAS, this august Body finds the request justifiable and for the purpose of protecting the interest of the City of Ormoc, hence, should be given due course;

FOREGOING PREMISES CONSIDERED, on motion of Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Claudio P. Larrazabal and Sotero M. Pepito; be it
