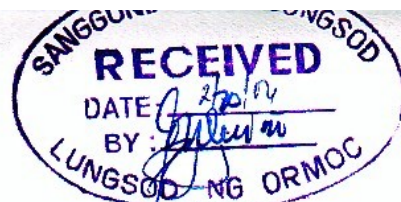
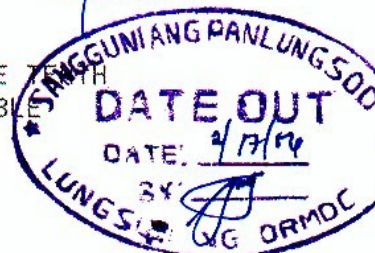

A RESOLUTION REQUESTING THE NATIONAL GOVERNMENT THROUGH  
THE SECRETARY, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS  
HONORABLE HERMOGENES EBDANE, JR., TO TURN OVER TO THE  
CITY GOVERNMENT OF ORMOC THE LOTS ACQUIRED DURING THE  
IMPLEMENTATION OF THE JICA FLOOD MITIGATION PROJECT.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 15  
February 2006 from the Office of the City Mayor re: Resolution No. 1  
series of 2006 of the Flood Mitigation Committee entitled: "A  
RESOLUTION REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE  
PASSAGE OF A RESOLUTION REQUESTING THE NATIONAL GOVERNMENT THROUGH THE  
DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) SECRETARY, HON.  
HERMOGENES EBDANE, JR., TO TURN OVER THE CITY GOVERNMENT OF ORMOC THE  
LOTS ACQUIRED DURING THE IMPLEMENTATION OF THE JICA FLOOD MITIGATION

WHEREAS, said resolution mentions of the desire of the City  
Government of Ormoc to establish eco-tourism development projects on the  
vacant lots acquired by the DPWH along the JICA Flood Mitigation Project  
at Anilao & Malbasag areas;

WHEREAS, the Flood Mitigation Committee has agreed that parks and  
recreational facilities such as but not limited to, fitness trail,  
basketball court, skating rink and Kiosks may be allowed provided they  
cannot obstruct or hamper repair and maintenance activities and that  
funding for the said proposed projects will be shouldered by the LGU-  
Ormoc;

WHEREAS, however, the properties herein mentioned are not owned by  
the City Government of Ormoc, therefore, it has no legal basis to  
implement projects on properties owned by the National Government hence,  
this request;
