APARIS I TO RELEASE THE SUM OF FIFTY THOUSAND PESOS (P50,000.00) AS FINANCIAL ASSISTANCE OF THE SANGGUNIANG PANLUNGSOD NG ORMOC TO THE RECENT LANDSLIDE VICTIMS IN BARANGAY GUINSAUGON, ST. BERNARD, SOUTHERN LEYTE, TO BE TAKEN FROM THE ACCOUNT GRANTS AND DONATIONS OF THE SANGGUNIANG PANLUNGSOD NG ORMOC.

WHEREAS, Barangay Guinsaugon which is located in the Municipality of St. Bernard, Southern Leyte has suffered a massive landslide causing damage to life and properties amounting to millions of pesos;

WHEREAS, having been declared as calamity area, the same is badly in need of financial and material assistance to save lives and for them to start anew;

WHEREAS, the Sangguniang Panlungsod ng Ormoc, having felt the needs of the victims in the affected area, is extending its help by way of financial assistance in the amount of FIFTY THOUSAND PESOS (P50,000.00);

WHEREAS, the City Treasurer through a Certification dated 21 February 2006 has certified that fund is available to be taken from the account Grants and Donations of the Sangguniang Panlungsod, subject however, to accounting and auditing rules and procedures;
