WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 15 ebruary 2006 from the Office of the City Mayor urgently requesting for passage of a resolution to charge to the CY 2006 Annual Budget under the of non-office provision for prior year's obligation the amount FOURTEEN THOUSAND SIX HUNDRED TWENTY FIVE PESOS (\$14,625.00) as payment for the Incentives of Barangay Tanods of Barangays Mas-in and Labrador for the period October 01, 2005 to December 31, 2005;

WHEREAS, the City Budget Officer through 4th Indorsement dated February 2006 has reiterated that authority be granted the City Accountant to charge obligation against current appropriation Provision for Prior Year's Obligation - a non - office item under the city's CY 2006 Annual Budget;
