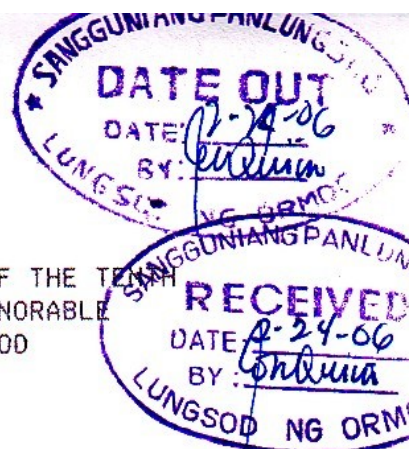

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE TO
CURRENT APPROPRIATION THE INCENTIVES OF BARANGAY TANODS
OF BARANGAYS MAS-IN AND LABRADOR FOR THE PERIOD OCTOBER
01, 2005 TO DECEMBER 31, 2005 IN THE AMOUNT OF FOURTEEN
THOUSAND SIX HUNDRED TWENTY FIVE PESOS (P14,625.00).

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 15
February 2006 from the Office of the City Mayor urgently requesting for
passage of a resolution to charge to the CY 2006 Annual Budget under the
account of non-office provision for prior year's obligation the amount
of FOURTEEN THOUSAND SIX HUNDRED TWENTY FIVE PESOS (P14,625.00) as
payment for the Incentives of Barangay Tanods of Barangays Mas-in and
Labrador for the period October 01, 2005 to December 31, 2005;

WHEREAS, the City Budget Officer through 4th Indorsement dated 21
February 2006 has reiterated that authority be granted the City
Accountant to charge obligation against current appropriation -
Provision for Prior Year's Obligation - a non - office item under the
city's CY 2006 Annual Budget;
