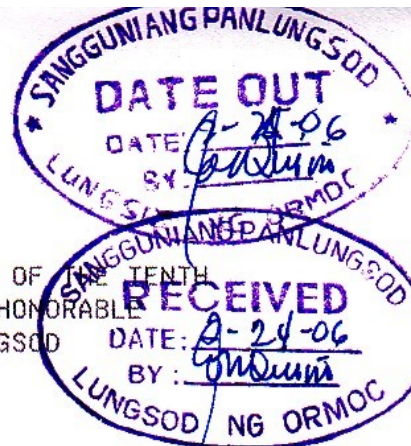

RESOLUTION NO. 2006-039

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST PRIOR YEAR'S OBLIGATION, A NON-OFFICE ACCOUNT OF THE CITY'S ANNUAL BUDGET THE AMOUNT OF TWO HUNDRED NINETEEN PESOS AND 22/100 (P219.22) REPRESENTING SALARY STEP INCREMENT OF MR. LUIS CON-UI, EFFECTIVE DECEMBER 1, 2005.

WHEREAS, this Sanggunian is in receipt of a letter dated 02 February 2006 from the Honorable City Mayor Eric C. Codilla, requesting that a resolution be passed authorizing the City Accountant to charge the sum of TWO HUNDRED NINETEEN PESOS AND 22/100 (P219.22) against Provision for Prior-Year's Obligation a non-office account of the City's Annual Budget, CY 2006 representing salary step increment of MR. LUIS CON-UI, effective December 1, 2005;

WHEREAS, the City Budget Officer through 3rd Indorsement dated 21 February 2006, has reiterated that said obligation be charged against current appropriation - Provision for Prior Year's Obligation, a non-office item of the city's Annual Budget, CY 2006;

WHEREAS, the City Treasurer through a certification dated 21 February 2006, has certified that fund is available for said purpose subject however to the usual accounting and auditing rules and procedures;
