## RESOLUTION NO. 2006-043

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.CODILLA TO UTILIZE THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (\$400,000.00) FROM THE 5% BUDGETARY RESERVE (CALAMITY FUND) AS ASSISTANCE TO THE LANDSLIDE VICTIMS OF ST. BERNARD, SOUTHERN LEYTE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 20 February 2006 from the Office of the City Mayor urgently requesting for the passage of a resolution authorizing the City Mayor Hon. Eric C. Codilla to utilize the amount of FOUR HUNDRED THOUSAND PESOS (\$400,000.00) from the 5% Budgetary Reserve (Calamity Fund) as assistance to St. Bernard, Southern Leyte landslide victims and other expenses in connection thereto broken down as follows:

Cash Aid - P200,000.00
Commodities/Food items - 80,000.00
Fuel Expenses - 40,000.00
Other Expenses - 80,000.00
TOTAL P400,000.00

WHEREAS, it can be recalled that Barangay Guinsaugon, St. Bernard, Southern Leyte suffered from a devastating landslide which caused extensive damage to lives and properties;

WHEREAS, the City Government of Ormoc, mindful of the plight of the residents of the affected area sympathizes with them and commiserates with them in their time of need;

WHEREAS, this Sanggunian has considered said request reasonable and meritorious, hence, be accorded due course of action:

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.CODILLA TO UTILIZE THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (\$400,000.00) FROM THE 5% BUDGETARY RESERVE (CALAMITY FUND) AS ASSISTANCE TO THE LANDSLIDE VICTIMS OF ST. BERNARD, SOUTHERN LEYTE;

RESOLVED, FURTHER, to suggest and recommend that the Non. City Mayor Eric C. Codilla course the cash component of the city's donation in the amount of \$200,000.00 through the Provincial Disaster Coordinating Council (PDCC) of the Province of Southern Leyte in the same way that the Sanggunian's cash assistance is channelled;
