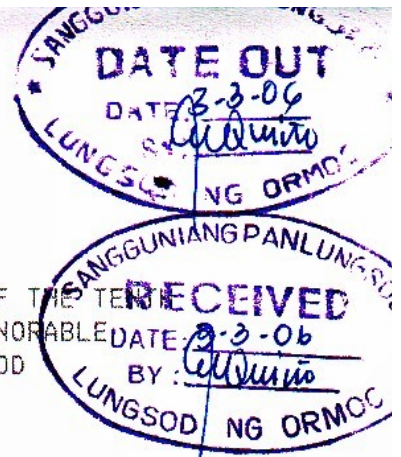

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO INITIATE DEVELOPMENT PROJECTS AT EVSU CAMPUS LOCATED AT BARANGAY PATAG, THIS CITY, FOR THE BENEFIT AND IN ACCORDANCE WITH THE REQUEST OF THE PRESIDENT OF THE EASTERN VISAYAS STATE UNIVERSITY (EVSU);

WHEREAS, this Sanggunian is in receipt of the 1st Indorsement dated 26 January 2006 from the Honorable City Mayor Eric C. Codilla urgently requesting for the passage of a resolution granting him authority to initiate development projects at the EVSU Campus located at Brgy. Patag, this city, in behalf of Eastern Visayas State University (EVSU);

WHEREAS, of significance to state in here is the letter dated 23 January 2006 from University President Bonifacio S. Villanueva, Ed. D. addressed the Honorable Eric C. Codilla, City Mayor of Ormoc informing the latter that the university's development efforts remain at the planning stage due to financial constraints;

WHEREAS, because of this predicament, EVSU earnestly requests technical and financial assistance from the City of Ormoc through the Honorable City Mayor and the Sangguniang Panlungsod for the development of the University Campus at the five (5) hectares land donated by the PAL Enterprises considering that their Deed of Donation for EVSU will soon expire;
