RESOLUTION NO. 2006-046

PRESOLUTION RETURNING TO THE SANGGUNIANG PAMBARANGAY OF DISTRICT XII, THIS CITY, THEIR ORDINANCE NO. 01, SERIES OF 2006, ENTITLED: "AN ORDINANCE DESIGNATING LOPEZ JAENA STREET AS NO PARKING ZONE AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF" FOR THE REASON THAT IT IS ULTRA VIRES.

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 01, Series of 2006 of the Sangguniang Pambarangay of District XII, this city, entitled: "AN ORDINANCE DESIGNATING LOPEZ JAENA AS NO PARKING ZONE AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF, submitted for review as required by Section 57 of the LGC, which in relation to Article III of the IRRLGC, which in part states:

"(a) with ten (10) days after its enactment, the sangguniang barangay shall furnish copies of all barangay ordinance to the sangguniang panlungsod or sangguniang bayan concerned for review as to whether the ordinance is consistent with law and city or municipal ordinances", (Note aforementioned Barangay Ordinance was enacted on January 21, 2006, however, copy thereof was received by the SP on February 23, 2006, only)

WHEREAS, the purpose of subject ordinance is meritorious and commendable, however, unfortunately, Sangguniang Pambarangays are not empowered to enact such kind of ordinance, as the subject matter thereof, is reserved to the Sangguniang Panlungsod as provided for in Section 458, par. (a), subpar. (5), (v) and (vi) of the LGC, in relation to Art. 99, par (a), subpar. (5), (v) and (vi) of the IRRLGC, the pertinent portion of which reads;

Ch

- "(v) Regulate the use of streets $x \times x$.
- (vi) Regulate traffic on all streets $x \times x$

and, moreover, Lopez Jaena Street which is proposed to be a "NO PARKING ZONE" is not entirely located within the territorial jurisdiction of Brgy. Dist. XII as it is also shared by Dist. XI, and therefore could not be proper subject of the Ordinance of Brgy. Dist. XII, and finally, as the subject Ordinance contains a penal sanctions for the violation thereof, the more that if should be emphasized that its enactment is ultra vires;

WHEREAS, considering the merits and the commendable objectives of subject Ordinance, this Sanggunian shall give it a serious study for its subsequent enactment;

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Mariano Y. Corro, Chairman Committee on Laws & Ordinances, severally seconded by City Councilors Eduardo P. Tan, Ruben R. Capahi & Manuel T. Fiel; be it
