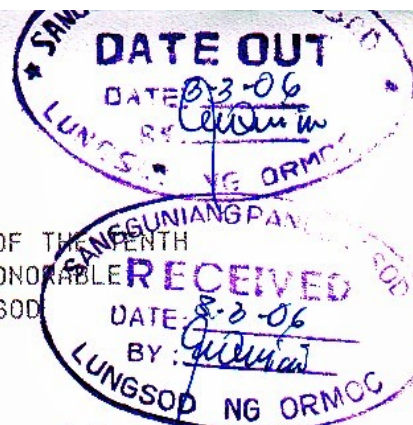

A RESOLUTION INTERPOSING NO OBJECTION TO THE PROPOSED  
INDUSTRIAL SAND AND GRAVEL EXTRACTION PROJECT OF MRS.  
LETECIA L. EMBAYARTE ALONG TIGBAWAN RIVER, BARANGAY  
CAN-UNTOG, THIS CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated 01 August  
2005 from MRS. LETECIA L. EMBAYARTE, requesting for a resolution  
interposing no objection to her sand and gravel operation at Tigbawan  
River, Brgy. Can-untog, this city;

WHEREAS, the Ormoc City Mining Regulatory Board on its Regular  
Meeting on October 12, 2005 passed Resolution No. 2005-08 endorsing to  
the Honorable City Mayor the industrial sand and gravel application of  
applicant Mrs. Letecia L. Embayarte;

WHEREAS, the Barangay Council of Brgy. Can-untog passed Resolution  
NO. 010 s. 2005, entitled: "A RESOLUTION INTERPOSING NO OBJECTION ON THE  
PROPOSED INDUSTRIAL SAND AND GRAVEL EXTRACTION PROJECT OF LETECIA L.
