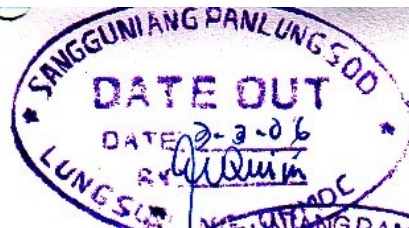

A RESOLUTION INTERPOSING NO OBJECTION TO THE PROPOSED
COMMERCIAL SAND AND GRAVEL EXTRACTION PROJECT OF MR.
DANILO M. PASCUAL ALONG PANILAHAN RIVER, BARANGAY
MABINI, THIS CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated March 22, 2005 from MR. DANILO M. PASCUAL, requesting for a resolution interposing no objection on his sand and gravel operation at Panilahan River, this city;

WHEREAS, the Ormoc City Mining Regulatory Board on its Regular Meeting on July 27, 2005 passed Resolution No. 2005-07 endorsing to the Honorable City Mayor the commercial sand and gravel application of applicant, Danilo M. Pascual;

WHEREAS, the Barangay Council of Brgy. Mabini passed Resolution No. 2005-00, entitled: "A RESOLUTION INTERPOSING NO OBJECTION TO THE GRANTING OF PERMIT BY THE HON. CITY MAYOR ERIC C. CODILLA TO MR. DANILO PASCUAL, FOR SAND AND GRAVEL EXTRACTION AT THE PANILAHAN RIVER, ON CONDITION THAT IRRIGATION CANAL/DAMS DAMAGED DURING ITS OPERATION (SIC) SHALL BE REPAIRED/REPLACED BY THE OPERATOR";
