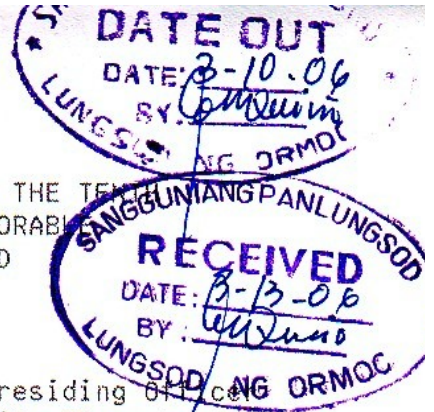

RESOLUTION NO. 2006-053

A RESOLUTION ADOPTING BARANGAY RESOLUTION NO. 48 SERIES OF 2005 OF BARANGAY LAO, THIS CITY, ENTITLED: "A RESOLUTION ADOPTING THE BARANGAY FISHERY AND AQUATIC RESOURCE MANAGEMENT COUNCIL (BFARMC) AND LAO FISHERFOLKS ORGANIZATION JOINT RESOLUTION AND ALSO REQUESTING THE SANGGUNIANG PANLUNGSOD TO SUPPORT AND DECLARE THE AREA IN BETWEEN THE END PART OF OLD PAGSANGAAN, NALIWATAN RIVER AND PORTION OF ORMOC BAY OF BARANGAY LAO AS FISH SANCTUARY OR MARINE RESERVE ZONE, HAVING AN AREA OF (4.0000 HAS) FOUR HECTARES MORE OR LESS TO EFFECTIVELY IMPLEMENT THIS PROJECT THAT AIMS TO PROTECT AND PRESERVE THE MARINE AND COSTAL (SIC) HABITAT OF THIS BARANGAY AND FOR FURTHER FUTURE LIVELIHOOD SUPPORT OF BARANGAY LAO FISHERFOLKS AND ADJACENT BARANGAYS".

WHEREAS, this Sanggunian is in receipt of Resolution No. 48 series of 2005 of the Barangay Council of Barangay Lao, this city entitled: "A RESOLUTION ADOPTING THE BARANGAY FISHERY AND AQUATIC RESOURCE MANAGEMENT COUNCIL (BFARMC) AND LAO FISHERFOLKS ORGANIZATION JOINT RESOLUTION AND ALSO REQUESTING THE SANGGUNIANG PANLUNGSOD TO SUPPORT AND DECLARE THE AREA IN BETWEEN THE END PART OF OLD PAGSANGAAN, NALIWATAN RIVER AND PORTION OF ORMOC BAY OF BARANGAY LAO AS FISH SANCTUARY OR MARINE RESERVE ZONE, HAVING AN AREA OF (4.0000 HAS) FOUR HECTARES MORE OR LESS TO EFFECTIVELY IMPLEMENT THIS PROJECT THAT AIMS TO PROTECT AND PRESERVE THE MARINE AND COSTAL (SIC) HABITAT OF THIS BARANGAY AND FOR FURTHER FUTURE LIVELIHOOD SUPPORT OF BARANGAY LAO FISHERFOLKS AND ADJACENT BARANGAYS";

WHEREAS, said resolution was passed in view of the response of coastal communities to the deterioration of the habitat that affect their livelihood particularly in the said area;



WHEREAS, this august Body believes that such move could be of great help to the residents in the said area specially as far as their livelihood is concerned;

WHEREFORE, foregoing premises considered on motion of City Councilor Soter M. Pepito, Chairman, Committee on Agriculture, jointly seconded by City Councilors Fe S. Lladoc & Mariano Y. Corro; be it


