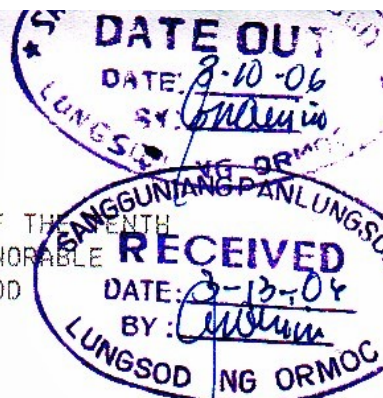

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.  
CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF  
AGREEMENT (MOA) BY AND BETWEEN THE LOCAL GOVERNMENT  
UNIT OF ORMOC CITY AND THE NATIONAL FOOD AUTHORITY -  
LEYTE PROVINCIAL OFFICE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 03  
March 2006 from the Office of the City Mayor requesting for the passage  
of a resolution authorizing him to sign a Memorandum of Agreement (MOA)  
between LGU Ormoc and National Food Authority, Leyte Provincial Office;

WHEREAS, under the said MOA, LGU Ormoc has requested NFA to allow  
them to purchase rice on credit for relief operations whenever a state  
of calamity is declared in the locality and for stockpiling in  
preparation for eventualities/emergencies that may occur at any given  
time;

WHEREAS, this august Body believes that said request is reasonable,  
hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on joint motion of City  
Councilor Mariano Y. Corro and Sotero M. Pepito, Chairman, Committee on  
Laws & Ordinances and Committee on Agriculture, respectively, jointly  
seconded by City Councilors Eduardo P. Tan and Manuel T. Fiel; be it
