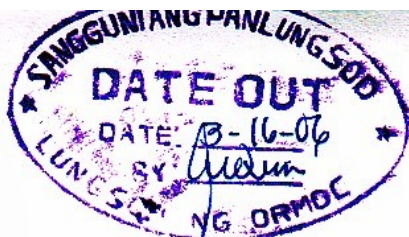

ADOPTED, March 16, 2006.


