

RESOLUTION NO. 2006-066

A RESOLUTION RETURNING TO THE SANGGUNIANG PAMBARANGAY OF
TONGONAN, THIS CITY, THEIR SUPPLEMENTAL BUDGET NO. 01
FOR THE REASON THAT THE OBJECT OF APPROPRIATION THERETO
IS NOT IN CONFORMITY WITH JOINT CIRCULAR NOS. 95-01 AND
98-01 OF THE DEPARTMENT OF INTERIOR AND LOCAL
GOVERNMENT (DILG) AND DEPARTMENT OF ENERGY (DOE).

WHEREAS, submitted to this Sanggunian is the Supplemental Budget
No. 01 of the Sangguniang Pambarangay of Tongonan, this city, for review
as mandated by the provisions of the LGC;

WHEREAS, the object of aforementioned Supplemental Budget is "the
Electrification Project: Provision Installation of Street Lighting
Fixtures (160 sets) @ Purok I, Highway Proper, Campsite Lower, Campsite
Upper, Purok 8 and Barangay Proper of Barangay Tongonan, Ormoc City from
80% Royalty Share P10,807,000.00" and the funding thereof is to be taken
from 80% of the Royalty share;

WHEREAS, as provided for Circular Nos. 95-01 and 98-01 "at least
80% of the national wealth proceeds derived from the development and
utilization of energy resources shall be applied solely to lower the
cost of electricity in the LGU where the source of energy is located";

WHEREAS, the project to be funded out of the 80% Royalty Share of
the Barangay, as shown in their Supplemental Budget No. 01 will not in
any way lower the cost of electricity in the Barangay, hence not in
conformity with the aforecited Joint Circular Nos. 95-01 and 98-01 of D
I L G and D O E;

WHEREAS, the Under Circular No. 98-01, Section 2, par. 2.4, subpar. c, provides:

"Any use of the national wealth proceeds outside the prescriptions in the DILG-DOE Circular No. 95-01 of October 31, 1995 and this Circular shall require the approval of the DILG Secretary."

WHEREAS, the Sangguniang Pambarangay of Tongonan is advised to avail of the aforementioned provision of Joint Circular No. 98-01, so that once approved, they can implement their projects utilizing the 80% of their Royalty;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RETURNING TO THE SANGGUNIAN PAMBARANGAY OF TONGONAN, THIS CITY, THEIR SUPPLEMENTAL BUDGET NO. 01 FOR THE REASON THAT THE OBJECT OF APPROPRIATION THERETO IS NOT IN CONFORMITY WITH JOINT CIRCULAR NOS. 95-01 AND 98-01 OF THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) AND DEPARTMENT OF ENERGY (DOE);
