A RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF AGRARIAN REFORM (DAR) THROUGH ITS REGIONAL DIRECTOR, REGION 8, HON. HOMER P. TOBIAS, TO RELEASE THAT PARCEL OF LAND KNOWN AS LOT 5503-D, CAD. 08-001986-D (OLT) DESCRIBED IN AND COVERED BY TCT NO. T-589, REGISTRY OF DEEDS FOR THE CITY OF ORMOC, UNDER THE COVERAGE OF THE COMPREHENSIVE AGRARIAN REFORM PROGRAM, SO THAT THE SAME CAN BE UTILIZED FOR THE LOW COST SOCIALIZED HOUSING PROGRAM OF THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this Sanggunian is in receipt of a communication dated March 09, 2006, from the Honorable City Mayor Eric C. Codilla requesting "to pass a resolution in an urgent basis showing the intent of the City that the subject land area be earmarked for Low Cost Socialized Housing";

WHEREAS, the land referred to in the aforementioned letter of the City Mayor is the land formerly owned by the late City Councilor Benjamin Lladoc located at Brgy. Sto. Nino, this city, and now covered by and described in TCT No. T-589, Registry of Deeds for the City of Ormoc, in the name of Teofisto Ladiza Dayang, Et. Al."

WHEREAS, one of the projects of the City Government of Ormoc is the establishment of Low Cost Socialized Housing to cater to needs of the urban poor of this city, so they can have a house they can call their own;

WHEREAS, subject property is suitable for Low Cost Socialized Housing as it is not quite far from the city proper of Ormoc, and is accessible by land transportation;

WHEREAS, the Department of Agrarian Reform through its Regional Director, Region 8, Hon. Homer P. Tobias, is respectfully requested to assist the City Government of Ormoc in realizing one of its important project, "Low Cost Socialized Housing Program" which is intended to benefit the poor people who does not have a house of their own to make available that parcel of land covered by and described in TCT No. T-589, Registry of Deeds for the City of Ormoc;


