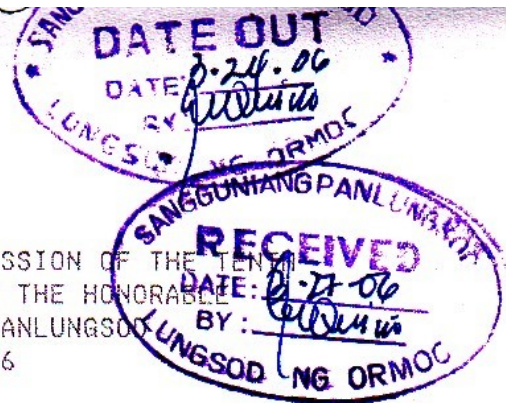

PROGRAM (PCL-CLLEP) ON MARCH 31 - APRIL 2, 2006 AT ILOILO CITY;




