WHEREAS, this Sanggunian is in receipt of a letter dated 23 March
2006 from the Office of the City Mayor urgently requesting for a passage
of a resolution granting authority to the Honorable City Mayor Eric C.
Codilla to enter into and sign a Memorandum of Agreement (MOA) by and
among the Department of Agriculture & Regional Field Unit 8, represented
by Regional Executive Director Leo P. Cañeda, CESO III, the House of
Representatives, represented by Honorable Eufrocino M. Codilla, Sr,
Representative, 4th District of Leyte and the Local Government of Ormoc
City, represented by Hon. Eric C. Codilla, City Mayor of Ormoc;

WHEREAS, said MOA involves the transfer of TEN MILLION PESOS
(P10,000,000.00) by the DA-RFU 8 to the LGU of Ormoc City for the
implementation of livelihood program in the 4th District of Leyte

Representative as implementer of the livelihood program of the said
District of Leyte and has signified its willingness;



RESOLVED, FURTHER, that a copy of the final and notarized contract be submitted to the Sangguniang Panlungsod ng Ormoc for information and file;


