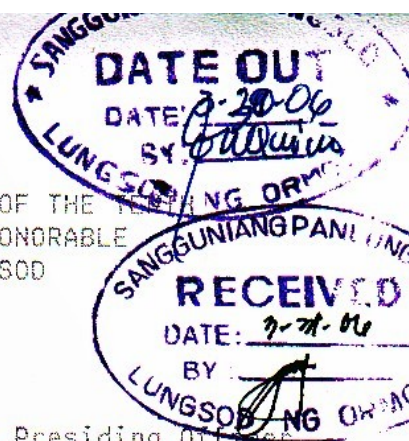

WHEREAS, this Sanggunian is in receipt of CDC Executive Committee
