


RESOLUTION NO. 2006-078

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE NEGOTIATED CONTRACT WITH PHILIPPINE RIGID CONSTRUCTION FOR THE REASON THAT 80% OF THE WORK HAS ALREADY BEEN ACCOMPLISHED AND THE NEGOTIATED CONTRACT SHALL BE PERFECTED BEFORE THE 100% COMPLETION OF THE NEW CITY HALL BUILDING PROJECT.

WHEREAS, this Sanggunian is in receipt of a letter dated 29 March 2006 from the Office of the City Mayor, this city addressed to the Honorable 10th Sangguniang Panlungsod, thru the Honorable Vice Mayor & Presiding Officer requesting on an urgent basis for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign the Negotiated Contract with the Philippine Rigid Construction regarding the New City Hall Building project;

WHEREAS, said request to enter into and sign for a Negotiated Contract with Philippine Rigid Construction is based on the reason that 80% of the work has already been accomplished and the Negotiated Contract shall be perfected before the 100% completion of the project at the New City Hall Building;

WHEREAS, having complied with the requirements for a Negotiated Contract, this august Body through the representation of the Honorable Chairman, Committee on Infrastructure, has considered said request reasonable, hence the same be given the necessary course of action;




