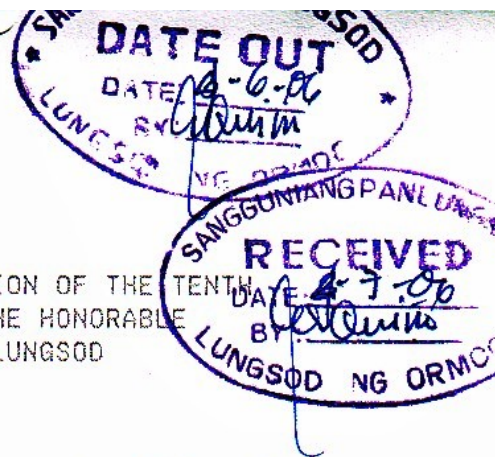

RESOLUTION NO. 2006-080

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN AND ACCEPT THE DEED OF DONATION MADE AND EXECUTED BY THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 20 March 2006 from the Office of City Mayor, this city requesting for the passage of a resolution granting him authority to accept and sign the Deed of Donation made and executed by the Department of Social Welfare and Development, for and in behalf of the City Government of Ormoc;

WHEREAS, said donation refers to the transfer of Fifteen (15) units of computers for the implementation of the Information Technology Literacy Program for the Out-of School Youth and Youth with Disability (SCALA Project) sponsored by Engineers Without Borders of Canada;

WHEREAS, it can be recalled that this august Body passed S.P. Resolution No. 2005-143 dated 18 August 2005 entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, REGARDING THE IMPLEMENTATION OF THE SCALA-INFORMATION AND COMMUNICATION TECHNOLOGY FOR DISADVANTAGED YOUTH SPONSORED BY ENGINEERS WITHOUT BORDERS OF CANADA";


