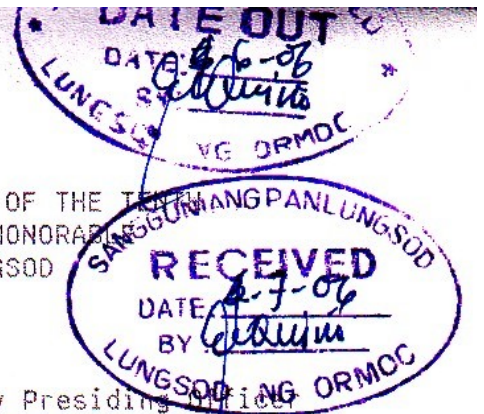

ADOPTED, April 06, 2006.


