

CODILLA TO ENTER INTO AND SIGN THE CONTRACT OF LEASE FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC AND FAST DISTRIBUTION CORPORATION (NESTLE) - TACLOBAN BRANCH FOR THE RENTING OF SPACE PROVIDED FOR ADVERTISING MATERIALS ON BUILDINGS A, B & C LOCATED AT THE NEW PUBLIC MARKET, THIS CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 04 April 2006 from the Office of the City Mayor urgently requesting for the passage of a resolution giving authority to the Hon. City Mayor Eric C. Codilla, to enter into and sign the Contract of Lease for and in behalf of the City Government of Ormoc and FAST DISTRIBUTION CORPORATION (NESTLE) - Tacloban Branch;

WHEREAS, said contract of lease mentions of the renting of space provided for advertising materials on Buildings A, B & C located at the New Public Market, this city, under the terms and conditions agreed upon by the parties;


